\*\*\* The annual maintenance fee shall be charged upfront at the time of opening the account. The annual account maintenance fee for each subsequent year shall be charged on the anniversary day of the account opening. In case of failure to pay the account maintenance fee or the absence of **sufficient balance on the Customer's account, the account shall be closed.** In case of opening an account in a different or the same currency or opening accounts within the same day (excluding sub-accounts) for legal persons and individual entrepreneurs, the maintenance fee shall be charged up-front at the time of opening the account(s).

\*\*\*\* When sending required documents outside the Republic of Armenia, postage costs shall be additionally charged to the account holder.

\*\*\*\*\* Transfers shall be executed within one banking day.

\*\*\*\*\* If the amount of the transfer is already paid to the beneficiary or the beneficiary bank, the Bank shall not be held liable for the return of funds.

\*\*\*\*\* If the return of remitted amounts stems from inaccuracy within details provided by the Customer, the expenses of the Bank incurred due to the return shall be charged to the Customer.
